

"The Family Car" ESL Lesson on Used Motor Oil Recycling

The Family Car is a lesson designed for use in adult ESL (English as Second Language) classes. It introduces basic information about how and where to recycle used motor oil and filters for people who change their own oil. The lesson is currently taught in ESL programs in more than 20 counties in California.

The goal of the project is behavior change: proper recycling of oil and filters by people who have previously disposed of the wastes in the trash, down drains, or on the ground.

C²: Alternative Services developed the lesson with a \$300,000 grant from the California Integrated Waste Management Board. The grant-funded program was completed in late 2007 but local jurisdictions in most of the counties targeted by the grant have agreed to continue funding, and other counties have funded it as well. The program has several important elements:

- The lesson is tailored to each local area where it is taught, so that students receive specific information on oil recycling locations.
- Teachers in each area are given an orientation to the lesson and the key
 messages that students should learn about recycling oil and filters. Teachers are
 also provided with a stipend upon completion of a class record form.
- All class materials are provided to each ESL program, including various teaching aids.

So far we have analyzed class record forms and other data for more than 1200 classes, totaling over 22,000 students. The project is successful by several measures:

- An increase in collection of used motor oil in communities where the lesson is taught of about 100,000 gallons in the first year of the project. Analysis in subsequent years shows a continuing increase.
- Students in the ESL classes where the lesson is taught have a rate of DIYer oil
 changing more than twice the average of the general population. In addition
 recent immigrants are known to have a high rate of improper disposal.
- Very positive reviews of the lesson materials from ESL teachers who have used them
- High level of interest and participation in the lesson by adult ESL learners as reported by teachers
- Self-reported behavior change by students following their exposure to the lesson
- The project website www.thefamilycar.info is receiving thousands of 'hits' per month.

Teachers are enthusiastic about the lesson, both for its utility in teaching English, and for the content. They report a high level of student interest and involvement, and frequently relate that class discussion was lively and ranged widely into other environmental topics. We have received many requests for additional lessons with environmental themes.
