Re: Grant Program Update

### **USDA: Universal Waste Training**

ESJPA has been invited to submit a final grant application to provide regional rural training opportunities for handling universal waste in Butte, Imperial, Inyo, Mariposa, Modoc, Nevada, Sierra, Tehama and Trinity.

### **HD14-05-12: Inyo, Nevada, Trinity, and Tuolumne – Universal Waste Events**

The first of three month long events began with Nevada (Grass Valley) in April. In June, Nevada (Truckee) and Trinity (Hayfork and Weaverville) events will commence. Tuolumne plans to host a series of countywide collection/clean-up days throughout the summer for which this grant will provide assistance. Advertising for facilities in Inyo will continue to the end of 2007. We anticipate closing this grant by December 2007.

### **UOG8-05-3: Amador, Colusa, Mariposa, Siskiyou, Tehama, and Tuolumne – Used Oil Filter Exchange Events, Establish New Centers, Improve Existing Centers**

Oil filter exchange events will held from June and run through October 2007. Staff is finalizing advertising and premium orders. The establishment of two new centers in Mariposa and the improvement of existing centers in Mariposa and Tuolumne will commence in June as well. The start-up program for recycling empty oil bottles is on hold for 2007 due to the demise of Green Flame. If another vendor doesn't step in during 2007, a request to reallocate the funding will be submitted to CIWMB.

### **Department of Conservation – City/County Funding: Colusa**

Staff coordinated the appearance of Rock Steady Juggling at six (6) elementary/middle schools in Colusa County during May. In addition, a comprehensive Colusa County Recycling Guide (modeled after the successful Amador guide) was developed and will be distributed at each event.

### **Used Oil Block Grants**

UBG – 10<sup>th</sup> Cycle completed December 31, 2006 and the 11<sup>th</sup> Cycle (Alpine, Amador & Cities, Colusa & Cities, Lassen and Mariposa) is near completion. Staff is working with jurisdictions

on site improvements, new centers, outreach activities and advertising to close UBG11 and continue through UBG12 during 2007.

### **Grant Opportunities**

#### **Fiscal Year 2007/08: Household Hazardous Waste, 16th Cycle – Deadline: May 18, 2007**

- \$500,000 will be set aside for countywide coordination of sharps and continuation of u-waste collection system coordination and/or product stewardship.
- \$4,500,000 will be available to individual jurisdictions for competitive HHW facility planning, facility development or enhancement for sharps and u-waste, and for the development of innovative sharps and u-waste collection methods. Individual jurisdictions may request up to \$200,000 and multi-jurisdiction groups (two or more cities/counties) may request up to \$300,000. The competitive infrastructure grant term is from approximately September/November 2007 through April 2010.

#### **Fiscal Year 2007/08: Used Oil Block Grant, 13th Cycle – Deadline: June 1, 2007**

- UBGs are calculated at approximately \$0.27 per capita using the Department of Finance's population statistics. Small jurisdictions are guaranteed a minimum of \$5,000 per city and \$10,000 per county. Jurisdictions may apply regional and pool their funds.

#### **Farm and Ranch Clean-up Grants – Deadline: Continuous Applications Accepted**

- **Funding:** The grants are limited to \$50,000 per cleanup or abatement project, with a limit of \$200,000 per year for each eligible applicant.

#### **Targeted Rubberized Asphalt Concrete Incentive Grant Program (FYs 2005/06 and 2006/07) – Deadline: Continuous Applications Accepted**

Two million one hundred eighty-two thousand eight hundred and eighteen dollars (\$2,182,818) for FY 2006/2007, will be available for this grant program. For this offering, a per jurisdiction/entity limit based on the following categories applies:

- For southern jurisdictions: one hundred and fifty thousand dollars (\$150,000).
- For northern jurisdictions: one hundred and seventy-five thousand dollars (\$175,000).
- For rural jurisdictions (statewide): two hundred thousand dollars (\$200,000).
