Program Update

New Director Appointed to CalRecycle

Caroll Mortensen was appointed as CalRecycle's Director by Governor Brown in October.

Ms. Mortensen has an extensive background in the development of environmental policy and legislation. She most recently served as consultant for the State Senate Committee on Environmental Quality where she analyzed legislation and provided policy guidance related to solid and hazardous waste, and air and water quality. She also worked as chief consultant for the State Assembly Committee on Environmental Safety and Toxic Materials from 2005-2007, working on issues related to hazardous waste, green chemistry, pesticides, brownfields, and other related policy areas.

Prior to her work in the Capitol, she worked at the California Integrated Waste Management Board for 13 years in a variety of positions including legislative director.

Local Assistance and Market Development Division Update

Staff have completed nearly all of their Local Jurisdiction Annual Report Reviews, and most of your counties should have received a letter to that effect. As mentioned at our last meeting, next year after the 2011 annual reports are reviewed, a compliance review will begin for all reporting jurisdictions. Specific program implementation information in the 2011 Annual report notes will be particularly important. Site visits will be conducted to all jurisdictions to verify the level of diversion program implementation and assist with our analysis. Staff also continue their analyses of the State Agency Diversion and Buy Recycled Annual Reports.

Waste Reduction Awards Program (WRAP)

Announcement of the WRAP winners is scheduled to be announced December 13th at the CalRecycle Monthly meeting. As was mentioned at the last meeting, preliminary numbers indicate businesses reported more than 2.3 million tons of diverted materials and more than \$200 million in cost savings.

Regulatory Update

AB 341 -

75% Requirement and Per Capita Measurement

The 75% goal is measured as a per capita diversion goal, and will be measured on a statewide basis. Current jurisdiction per capita goals are unchanged and still are equivalent to a 50% diversion goal, unless the jurisdiction has an approved reduced goal. The AB939 50% "diversion" goal has not changed for each Jurisdiction, and will continue to be measured using per capita rates.

NDFE change

AB 341 changed the NDFE amendment process to an update process.

Two NDFE Guideline pages have been published to reflect the passage of AB 341. Previous guidelines for amending an NDFE page will be removed after Jan. 1 when the new law is in effect.

Informal Composting Regulatory Workshops on December 13, 2011 and December 21, 2011

A workshop was held on 10/18 to discuss 12 potential changes to Title 14 and Title 27. Regulatory areas include Compostable Materials, Transfer Processing, Permit Application Form, and Permit Exemptions. CalRecycle will hold two more informal workshops on December 13, 2011 and December 21, 2011 with intent to pursue rulemaking in 2012.

The <u>December 13, 2011 workshop</u> will be held during the CalRecycle Monthly Public Meeting and will address:

Issue 5 (Regulatory coordination of POTWs accepting food waste & FOG);

Issue 8 (Regulatory coordination of meat, fish, and poultry waste), Issue 10 (Clarify "processing" in agricultural material definition);

Issue 12 (Clarify "permitted maximum tonnage"); and

Issue 14 (EA Notification Inspection frequency language).

The <u>December 21, 2011 workshop</u> will be held at the CalEPA building in Conference Room 550 from 9:00 AM to 12:00 PM and will address:

Issue 1 (food waste definition); Issue 2 (Land application: disposal or beneficial use);

Issue 3 (On-site storage and 12,500 cubic yard limit);

Issue 4 (Odor complaints: beyond zero tolerance);

Issue 6 (Green waste contamination);

Issue 7 (Anaerobic Digestion facility permitting);

Issue 9 (Maximum metal concentrations consistency with federal regulations);

Issue 11 (Small-scale composting exclusions), and Issue 13 (Vermiculture).

CalRecycle / DTSC E-waste Workshop Held November 16th

CalRecycle and the Department of Toxic Substances Control (DTSC) held another electronic waste stakeholder workshop on Wednesday, November 16, 2011. The workshop, which was also webcast, continued discussions focusing on proposed changes to cathode ray tube (CRT) glass management regulations and associated impacts to the covered electronic waste (CEW) recycling payment system. DTSC staff reviewed proposed rule changes that could alter CRT treatment authorization conditions and allow for a wider range of management options. CalRecycle staff discussed what rule changes would be necessary in the CEW recycling program to accommodate an expanded range of CRT glass dispositions. Both departments also responded to comments and questions received from stakeholders since the September 26th workshop on the same topic.

DTSC anticipates filing emergency regulations with OAL in early January 2012. CalRecycle's e-waste program will then hold additional informal stakeholder meetings to consider changes to the CEW system rules, with a target of filing emergency rule changes with OAL in late February or early March.
